It has also been reported that body work and painting of cars are being performed outside and in the evenings.

11/21/16 Decision

Following the public hearing that was held on November 21, 2016 at the request of the Commissioner of Buildings as a result of your failure to comply with his request to clean up your lot and get rid of the junk cars that are currently stored on your lot; as well as reducing the number of cars on your lot to the number (20) for which you've been approved, **the Board voted unanimously to once again table any action until its May meeting.**

The Board took this action to allow you an additional amount of time (6 Months) to come into compliance with those conditions that are required to maintain a facility dedicated to carrying out said business (Used Car Dealer). All licensees must adhere to all conditions of the issued license.

This Board strongly recommends that you contact and meet with Danny Romanowicz, Commissioner of Buildings, to ensure that you fully understand what is expected of you in order for you to be in full compliance prior to this Board's May 22, 2017 meeting.

Short of full compliance, the Board must take action and, **as such, you are hereby ordered to bring with you your 2017 MV Class II License.** Depending on the Board's findings, you may be required to surrender your license until this matter is resolved.
